KNOWN FOR: Organics Recycling Collection

GreenRU provides food waste recycling programs by diverting food waste from landfills and recycling it into soil-enriching compost. Approximately 72 percent of the waste going to landfills is organic food waste. GreenRU is working to change this.

GreenRU is an organics recycling collection service started in 2011 by Chamness Technology, Inc., an organics recycling company based in Blairsburg, IA that has served the Midwest since 1986. GreenRU is unique because traditional waste haulers don't have the expertise or equipment for this service. Annually, GreenRU recycles more than 10 million pounds of inedible food product.

GreenRU provides route collection throughout Iowa, Illinois, Missouri, Nebraska and Minnesota. Waste stream audits, comprehensive customer training and program reporting are provided.



GreenRU earned the Murray J. Fox Recycling Innovation Award by the Iowa Recycling Association in 2014.
